MOTORCYCLE WAIVER AND RELEASE OF LIABILITY FORM

EVENT: ANY SPONSORED OR ORGANIZED BLUE KNIGHTS EVENTS

I, the undersigned, (on my own behalf and on behalf of my heirs, personal representatives, successors and assigned, hereinafter referred to as "RELEASOR(S)"), for and in consideration and the privilege of the opportunity to participate in the above-mentioned event, (hereinafter referred to as the "EVENT"), hereby agree to waive all claims against and release, indemnify, defend and hold harmless Blue Knights International, Blue Knights Texas XIII or any other Blue Knights chapter and their representatives, officers, members, directors, chairman, co-chairman, employees and agents, (hereinafter referred to as "SPONSOR(S)") in both their public and private capacities from and against any and all liability, claims, suits, losses, damages and causes of action, including all expenses of litigation and/or settlement for death, injury to, or death of any person, or for loss of, damage to, or of loss of use of any property arising out of or in connection with the RELEASOR(S) participation of this EVENT.

This release extends to any and all claims the RELEASOR(S) has or later may have against the SPONSOR(S) resulting from or arising out of the performance of the SPONSOR(S) duties whether or not such claims result from negligence (except willful neglect) on the part of any or all of the SPONSOR(S) with respect to the EVENT or with respect to the conditions, qualifications, instructions, rules or procedures under which EVENT is conducted or from any other cause.

IT IS UNDERSTOOD, THE RELEASOR(S) AGREES NOT TO SUE ANY OR ALL OF THE SPONSOR(S) FOR ANY INJURY RESULTING TO THE RELEASOR(S) OR HIS/HER PROPERTY ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF SPONSOR(S) DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENT.

RELEASOR(S) is experienced in and familiar with the operation of motorcycles and fully understands the risks and dangers inherent in motorcycling. The RELEASOR(S) is voluntarily participating in the EVENT and expressly agrees to assume the entire risk of any accidents or personal injury, including death, which the RELEASOR(S) may sustain and/or property loss as a result of the RELEASOR(S) participation in the EVENT, and any negligence (except willful neglect) on the part of any or all of the SPONSOR(S) in performing their duties.

By signing this release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the SPONSOR(S). This waiver of liability, release, indemnification and hold harmless agreement is valid from the date signed and through the duration of the EVENT.
